Statement of Program Accomplishments in 2015

2015 Mission Statement

Mercy Projects is a Christian 501c3 organization with a "Christ-centered, family-focused" vision of assisting vulnerable children, the poor and the widow. The methods differ in each country, but the overall philosophy remains the same.

We work to assist vulnerable children and families primarily in Ukraine. Other countries where we are active include Kosovo, Armenia, and Russia. Our ministry in Russia consists of financial support for national Russian missionaries in various regions of Russia to share the gospel in prisons, orphanages, and develop rehabilitation programs around the country.

2015 Mission Overview

Our approach is to strengthen families by wrapping services around them for their specific needs. These services are intended to provide support in four areas of life for vulnerable children and their families.

Education - We provide Education Centers to assist children in school work, extra curricular classes, and to connect them with a caring adult or teacher.

Medical - We provide an annual package of medical supplies necessary for all families. We contract with regional pharmacies across Ukraine to provide these supplies.

Emotional - We provide a Christian childcare worker to monitor each family in their caseload and to provide a support system for single mothers.

Spiritual - We emphasize our commitment to each child and family to not only hear the gospel but to see it lived out by our example and through the various ministries offered as sponsorship support.

In Russia, the national missionaries not only preach and teach inside prisons, they also mobilize the local church in the region of the prison to "participate in this local ministry opportunity." They encourage the local Russian churches throughout Siberia, the Urals, and the Caucuses to start Rehabilitation Homes and discipleship ministries for released prisoners.

In Ukraine, we identify the need of the child and family, and then offer a customized program that will assist in supporting the family and keep them together as a family. Our children's Christian camp ministry provide a spiritual emphasis in the lives of the sponsored children. Our primary approach in Ukraine is to always search for ways to strengthen and support existing families or alternatively, to support Christian Foster families.

In Southern California, we help provide temporary housing for vulnerable children through our affiliation with Safe Families For Children.

USA Domestic Ministry Focus

Partnership with Safe Families For Children / Olive Crest Agency

We work with SFFC as a regional Hub organization to recruit "host families" and "family friends" through local churches to provide housing and assistance to vulnerable children in our local community of Riverside County, California referred to as the Inland Empire. We represent this program primarily in the Murrieta / Temecula / Lake Elsinore / Perris / Hemet area.

The 2015 International Ministry Accomplishments

We successfully conducted 5 different one and two week camps for 470 vulnerable children, including 45 orphans from institutions. 636 children took part in our Child and Family Sponsorship programs. 46 Students received education scholarships. Two 10-day summer camps were held for needy Armenian young people in the Republic of Georgia on the Black Sea.

327 Families of children received Sponsorship Support

- * 305 Families received support in the Ukraine Child & Family Sponsorship Program.
- * 13 Families received monthly grocery vouchers in Kosovo.
- * Families in Kosovo are made up of widows and handicapped family members.

636 Children in Ukraine Child Sponsorship Program

Benefits to children include a Christian Camp experience to provide a fun and safe, loving environment where they are welcomed and see the Christian Faith modeled for them by their counselors. Camps are staffed with our trained counselors who place an emphasis on Spiritual development of the children. Camp themes include character, integrity, courage, and honesty using biblical references and personal testimonies.

Other benefits to children include: Medical Assistance, Birthday Presents; Christmas Presents; Letter Exchange with sponsors; English classes, Computer Training, and counseling with our area child care coordinator.

13 Families (73 children & family members) Kosovo Family Sponsorship Program

Families in Kosovo are primarily widows or those with special needs such as mental illness, blindness, or emotional trauma. The Kosovo program is designed to provide basic food necessities for these very poor children and their families. Families are able to redeem grocery vouchers each month for 50 Euros (\$65) at a local grocery store partner.

Mercy Projects missionaries and the local church regularly conduct bible studies and home visits with these predominantly and culturally Muslim families.

6 Pastors (Chaplains)

All of our national pastors (chaplains) reside in different areas of Russia. These men also work part time to support their families and ministries. They are part of local Russian churches and use their financial sponsorship to pay for expenses to travel and share Christ's love in adult prisons, in youth prisons, and with at-risk youth in orphanages.

46 Student Scholarships

In Ukraine, an extension of the Child Sponsorship Program is the Student Scholarship program. Those young people showing Christian character, good grades, and who agree to monitoring and counsel from our Student overseer, are eligible for a Student Scholarship of \$250-\$500 per semester depending on their level of higher education.
